# Call for urgent action to ban asbestos in Malaysia

Petaling Jaya, 20 November 2024: The Asian Ban Asbestos Network (A-BAN) including organizations in Malaysia who have gathered here for the A-BAN South East Asia Conference-Building Momentum: Banning Asbestos in Southeast Asia - calls on the Malaysian government to urgently impose an outright ban on all types of asbestos products being manufactured in the country and halt any further imports of chrysotile asbestos fibre. The network also calls for an urgent phasing out of consumer products containing asbestos.

Asbestos is a group of naturally occurring silicate minerals composed of long, thin fibres, with different shapes and colours. The WHO, ILO have advised very clearly there is no safe level of exposure to asbestos fibre. Asbestos is classified as a Group I carcinogen by the International Agency for Research on Cancer (IARC). Further, there is clear and unequivocal evidence of cancer and other disease risks associated with the continued use of asbestos. This fibre alone is the cause of 70% of global occupational cancers according to the ILO.

We are deeply concerned that workers continue to face serious risks from asbestos exposure, particularly in asbestos removal, demolition, building maintenance, ship-breaking and waste handling activities. We urge the Malaysian <u>Government to heed</u> clear advice from the World Health Organisation <u>that</u> "Asbestos-related diseases can be prevented and the most efficient way to prevent them is to stop the use of all forms of asbestos to prevent exposure." (WHO Factsheet Asbestos September 2024)

"The use of asbestos in Malaysia must be banned to eliminate the disease burden and the deaths caused by exposure to asbestos. Many countries have banned or are phasing out asbestos due to public health concerns and liabilities associated with asbestos. All diseases and deaths related to asbestos are entirely preventable and safer substitutes for asbestos do exist. Malaysia should have banned asbestos a long time ago, and a decision to ban will not impact the economy, in fact it will be a boon to the country by way of economic cost. Hence, we call on the government to take decisive action to ban asbestos," said Mohideen Abdul Kaveri, President of Consumers' Association of Penang.

We also note that in 2024 the Supreme Court of Indonesia has mandated labelling of all asbestos materials with a health warning, the USA has announced a full ban on asbestos, and the Malaysian Government has already agreed to cooperate with other countries in the region to transition to safer non-asbestos alternatives to asbestos, through the Indo-Pacific Economic Framework Agreement.
