#### The declaration of JPC-SE about Chrysotile

- "...Therefore, the Joint Policy Committee of the Societies of Epidemiology (JPC-SE), comprising epidemiologists from around the world:
  - Calls for a global ban on the mining, use, and export of all forms of asbestos;
  - Calls specifically on the major asbestos exporting countries Brazil, Canada, Kazakhstan, and Russia to respect the right to health by ceasing the mining, use, and export of asbestos, and providing transition assistance to their asbestos-mining communities;
  - Calls specifically on the major asbestos-using countries Brazil, China, India, Indonesia, Iran, Kazakhstan, Russia, Sri Lanka, Thailand, Ukraine, Uzbekistan, and Vietnam to cease use of asbestos...".

EBHPD, RTCCD, Vn-BAN, NCDs-VN make a request that Communist Party of Vietnam, National Assembly, Governmental agencies, social civil organizations, and national media:

- Whenever using evidence to discuss and analyse chrysotile-related issues, scientific documents published from the following sources must be employed:
  - Epidemiological associations, unions/societies of EPIDEMIOLOGY, PUBLIC HEALTH, the Ministries of Health of countries in the world;
  - International Agency for Research on Cancer, WHO
- Assist the Vietnamese Fatherland Front, Vietnam Union of Science and Technology Association, independent research organizations (EBHPD, RTCCD, Vn-BAN, NCDs-VN...) in supervising the Ministries (particularly the Ministry of Construction, the Ministry of Industry and Trade, the Ministry of Natural Resources and Environment) enforcing Official Letter 7307/VPCP-KGVX 19.9.2014
- Comply with recommendations of the Ministry of Health and those of WHO, ILO in Vietnam: "Protect the health of Vietnamese workers and people"
- Strive for the international mutual goal: "NO ASBESTOS" Asia Says NO to Asbestos!
